AFFIDAVIT OF NON-PERMANENT RESIDENCE

Proof of Residence Verification Process

Pursuant to California Education Code 48204, it is the Natomas Unified School Districts (NUSD) responsibility to verify residency for all students attending in our District. Therefore the following process has been set:

Proof of Residence should include the following:

**Utility Bill (SMUD or PG&E)
Telephone Bill (Land line or Mobile Bill)
Any official mail: Employer, State, Federal or Local Government Agency**

FIRST

Parent should provide one proof of residence to the school, along with this form, at the time of enrollment. This proof should include your name, the current address within NUSD boundaries as stated on the front of this form and one of the proof's listed above.

OR

If you do not have the required proof of residence, please provide along with this form, one of the following with the Legal Resident or Homeowner's name and address:

**The Legal Resident's proof of Home Ownership
Lease Agreement
SMUD or PG&E**

SECOND

To establish residency, parent must provide further proof to the school within **30 days** from the enrollment date by submitting two (2) forms of current mail, as listed above, which should have your name and current address as listed on the front of this form.

If verification is not received within 30 days, your student is subject to be disenrolled. Your cooperation in this matter will serve to provide quality education for all students in the Natomas Unified School District.
