Meeting called to order by Chair, Christopher McGreal at 7:15 p.m. and established a quorum with 6 members in attendance. One member of the public attending: Bob Moreno (interested in Measure J membership)

#### II. COMMUNICATIONS

#### a) Welcome/Introductions

Bill Young introduced Bob Moreno, newest member serving on Measure D representing the Tax Payer Organization and informed the group that Mr. Moreno is also applying to serve on Measure J. His application will go for recommendation to the next Board Meeting.

## IV. INFORMATION ITEMS

#### a) Committee Member Status

Bill Young reported that Measure J continues to advertise for a new CBOC member to fill vacancies. He informed the group that Carol Fieldhouse regretfully resigned. More members are welcome. Please encourage interested friends/community members to apply. The senior citizen organization is vacant. It was noted that some senior organizations have members of 55 years of age & older.

#### b) 2015-16 Performance Audit

Bill Young reported that items from the April 25, 2016 meeting are carried over to this meeting because there was no quorum at the last meeting to conduct business. He gave an overview of the RFP process, and announced the recommendation moving forward for review and action by the Board of Trustees will be to award the 3-year contract to Gilbert & Associates for \$10,000 per year. (He reported that the Districts' current auditors – Crowe Horwath have been notified that they will no longer conduct the Performance Audits for either of the Bond Measures. Crowe Horwath fee amount was \$8,000 per year. The fee for Gilbert & Associates is \$10,000 and a more extensive report is expected. He reported that the recommendation will be for Gilbert & Associates to conduct both Measure J and Measure D audits. Responding to questions, he clarified that the \$10,000 per year – totaling \$30,000 will come from the General Fund is just for the Measure J audit. (Measure D fees will be the same. RFP's were sent to 27 firms

with 3 firms responding; and 2 firms selected to interview. The third firm, Vargas & Company submitted an incomplete response. The second firm was James Marta & Company. He indicated that the time of year could have contributed to the low number of responses; because a larger return was expected.

#### c) Form 700

Completed Form 700's were collected at the April meeting. Those who have not submitted them yet, are encouraged to do so. Staff will send email reminders this week. It was noted that one form can be submitted that covers both Measure D and J.

#### d) Measure J Projects and Financial Update

Paul Anderson provided the following information relating to project activity and the financial update. Bill Young introduced and welcomed Vina Guzman, Director of Budget & Accounting.

The NCS STAR project is ready for the first day of school, the playground passed inspection, however the site work is not finished yet; it will be safe for first day of school. Slay inquired as to what the bond category letter is and Paul Anderson explained that it corresponds to voter's ballot language.

The **Westlake Charter School** project has just started, and already 2.4 million has been expended. The start of site work is doing well with Arntz Builders.

Bannon Creek, upgrades includes a 2 story - 16 classroom building. It is a modular building that was built in Manteca and delivered to our site and assembled in 7 days. Currently the teachers are scheduled to move into the new building in November and over winter break. Jennifer Slay stated that part of BC project is in funded by D and part is funded by J. Paul Anderson informed the committee that staff maintains separate resource codes that keep D and J expenditures separate. Jennifer Slay added you will not be able to discern which measure funded what work when performing a site audit. Moreno asked what DSA calls this type of building. Paul Anderson said it is treated as a permanent building.

The **Lighting Upgrades** project is complete. It included 4 sites, and exterior and interior of the gym at NHS. Project funds have not been exhausted and we show energy savings already.

LGA Upgrades project: The classrooms were ready for students to return before 8/10/15. The library needed extensive structural review by the inspector. The library will be a phenomenal space once complete.

**Heron** is just getting under way. The building plan is being reviewed by DSA and may have the DSA review complete tomorrow, 8/23/16.

The **Two Rivers** project was a library renovation and new furniture. The lights were backordered, and the furniture will be delivered on Sept 9 with a move in by Sept 12.

Natomas High School moved into B wing and F wing. There were structural issues on NHS, and all structural issues had to be reviewed by DSA. Jennifer Slay inquired what structural meant. Paul Anderson explained that a weight bearing wall was moved, and had to shore up the remaining walls and add a header. Bill Young added that these issues were surprises to the team. That often with construction projects there are surprises. Christopher McGreal inquired about impacts to the overhead costs. Paul Anderson informed the committee that all the change orders are not received as of yet and we don't have full scope of what the changes will cost. Bill Young included that we will pursue what we can as a District from the Architect and Contractor.

Discovery High School Culinary Upgrades project will open bids on Sept 1.

Natomas Park is a (stick/conventional) two story classroom building, with 12 spaces; it will go in back of the school. Move in is scheduled for next school year. Christopher McGreal asked about differences between stick/conventional vs. modular buildings. Paul Anderson and Bill Young explained that there are cost savings with modular and they are DSA approved. Stick/conventional allows for bigger classrooms and more design flexibility.

Bill Young added that there are 32 projects in the que right now and more will be added as the District is poised for the growth that is coming. Both Heron and Natomas Park experienced elays in completing the playground projects due to few playground construction workers available in the area. A variety of recess/playground equipment and games were sent to the schools for use in the interim. Completion is on track for end of September.

Bill Young narrated while viewing of various project photos featured on the District website.

Eric Stern moved to approve the January 26, 2016 meeting minutes. Motion seconded by David Kawada. Motion carried 6-0.

**Committee Chair:** Jennifer Slay nominated Eric Stern for Chair, motion seconded by Christopher McGreal. Motion carried by prior roll call 6-0.

**Committee Vice Chair:** Eric Stern nominated Christopher McGreal for Vice Chair, motion seconded by Joe Julio Motion carried by prior roll call 6-0.

## c) Approve Establishing Finance Standing Sub-Committee & Assign Members:

Jennifer Slay moved to approve establishing Finance Standing Sub-Committee, assigning Eric Stern, Joe Julio and Danielle Marshall as members; motion seconded by Eric Stern. Motion carried by prior roll call 6-0.

**d) 2016-17 Meeting Dates:** Jennifer Slay moved to keep the 4<sup>th</sup> Monday in August, October, January and April as meeting dates for the 2016-17 school year. Motion seconded by Christopher McGreal . Motion carried by prior roll call 6-0.

Meeting Dates: 8-22-16, 10-24-16, 1-23-17, and 4-24-17.

Eric Stern reported that he will reach out to staff and bring a proposed list of standing sub-committees to the next meeting. He will use the project list as a starting point to structure the list.

The next meeting will be held at a school site to get a look at the finished work on projects funded by the bond measures.

Committee Chair Eric Stern adjourned the meeting at 7:54 p.m. and announced the next meeting will be held October 24, 2016.
