Overview

In support of strengthening student academic achievement, **NATOMAS UNIFIED SCHOOL DISTRICT** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. The policy establishes the district's expectations and objectives for meaningful parent and family involvement and describes how the district will implement a number of specific parent and family engagement activities.

The **NATOMAS UNIFIED SCHOOL DISTRICT** agrees to implement the following requirements as outlined in Section 1116 of the ESEA, as amended:

Joint Development

AMERICAN LAKES SCHOOL will take the following actions to involve parents and family members in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I, Part A programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

American Lakes School will provide parents and family members the opportunity to review the school parents and family engagement policy each year within School Site Council (SSC) meetings, English Learner Advisory Council (ELAC) meetings, Coffee and Conversation meetings with the principal, as well as within the Annual Title 1 Parent Meeting. Annual Title I, Part A Meeting

The compact will be posted on school's website and a hard copy will be available in the front office.

School-Parent Compact

Staff and student leadership input will be used as well.
