NP3 Elementary School Consultation

Consultation with Labor

NP3 Elementary School employees are not represented by a labor group. NP3 held a COVID-19 training with staff on July 27, 2020. Topics included:

- Overview of COVID-19 in Sacramento County
- Basics of transmission
- Health and Safety in and outside the workplace
- Social Distancing
- Face Coverings
- Quarantine and Isolation
- In-person Instruction

The training included a guest speaker from Sacramento County Public Health and included opportunities for staff to ask questions and discuss concerns. COVID-19 and reopening have been a standing agenda item on weekly staff meetings. About 25% of teachers have expressed concerns about a return to in-person instruction. When NP3 reopens for in-person instruction, those teachers with concerns will be providing distance learning instruction to students who choose not to return in-person.

Consultation with Parents

NP3 Elementary School issued a parent survey regarding a return to in-person instruction on November 5, 2020. In the survey, parents were asked about their desire to have their student(s) return to in-person instruction and were offered a choice of modified in-person instruction (4 days per week), modified hybrid instruction (2 days per week), or full time distance learning. 53% of parents selected to continue Distance Learning. Given this number, it is possible to keep class sizes small and implement distancing measures with the modified full in-person instruction (4 days/week). 47% of students will return to in-person instruction. Monthly communications have been shared with parents regarding COVID-19 updates and reopening plans. The initial Reopening Guide was shared with families in August and parents were invited to a Back to School Night on Zoom where they were able to ask questions and share concerns. Parents who are not comfortable with the return to in-person instruction will be able to continue with Distance Learning for the remainder of the year.

Consultation with Community Organizations

NP3 Elementary School is an independent charter school within Natomas Unified School District (NUSD). The majority of staff are NP3 employees, however some services are provided by NUSD employees. Since March 2020, NP3 has coordinated with NUSD on safety protocols, PPE, cleaning and sanitization processes, testing, and case/contact reporting.

NP3 has coordinated closely with the NUSD special education teacher who works onsite to ensure compliance with established labor agreements in preparation for a return to in-person instruction. The special education instructor has expressed discomfort with in-person instruction while COVID-19 remains prevalent in our community and will be providing services to students virtually via Zoom even after in-person instruction resumes.

No other organizations provide services at NP3 Elementary School or are impacted by the reopening of NP3.
