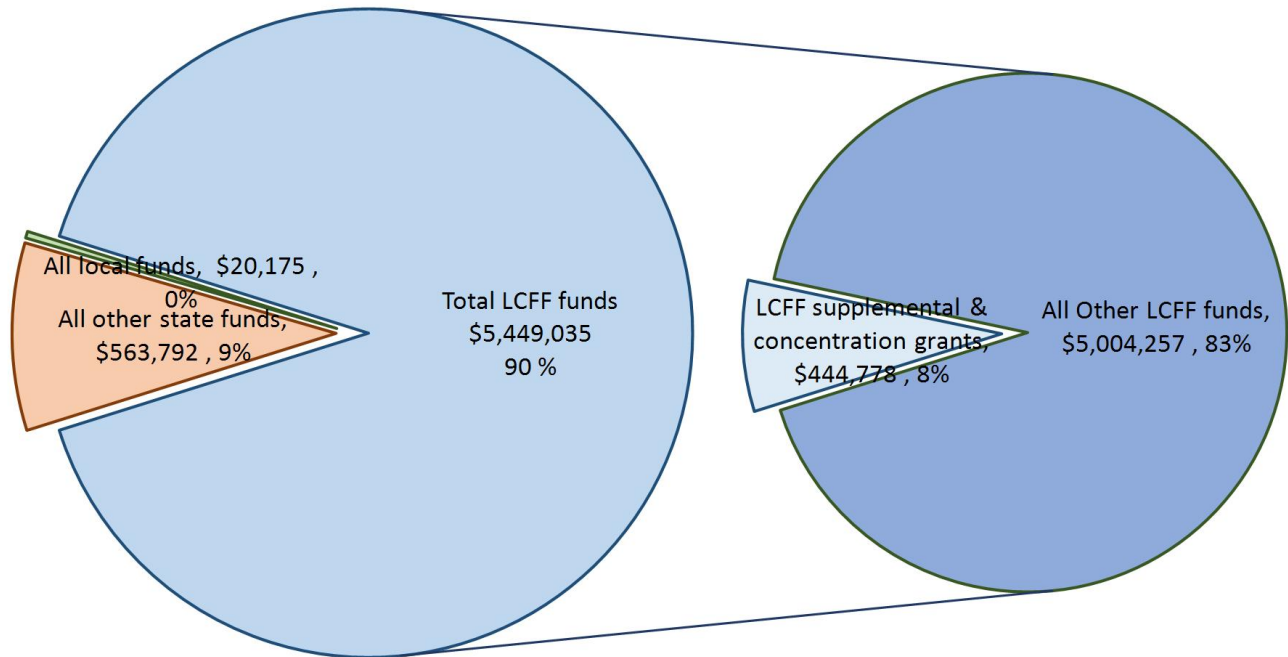

Projected Revenue by Fund Source

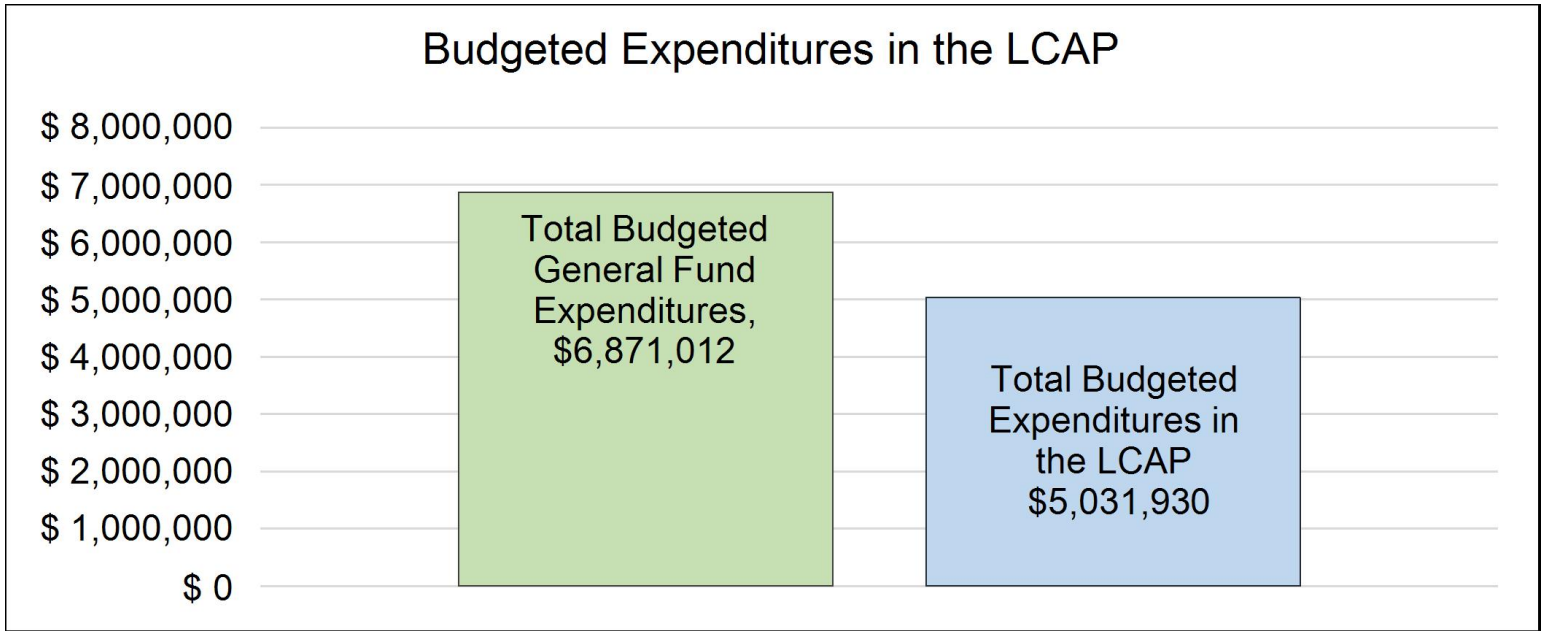


This chart shows the total general purpose revenue Natomas Pacific Pathways Prep. Middle School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Natomas Pacific Pathways Prep. Middle School is \$6,033,002, of which \$5,449,035 is Local Control Funding Formula (LCFF), \$563,792 is other state funds, \$20,175 is local funds, and \$ is federal funds. Of the \$5,449,035 in LCFF Funds, \$444,778 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

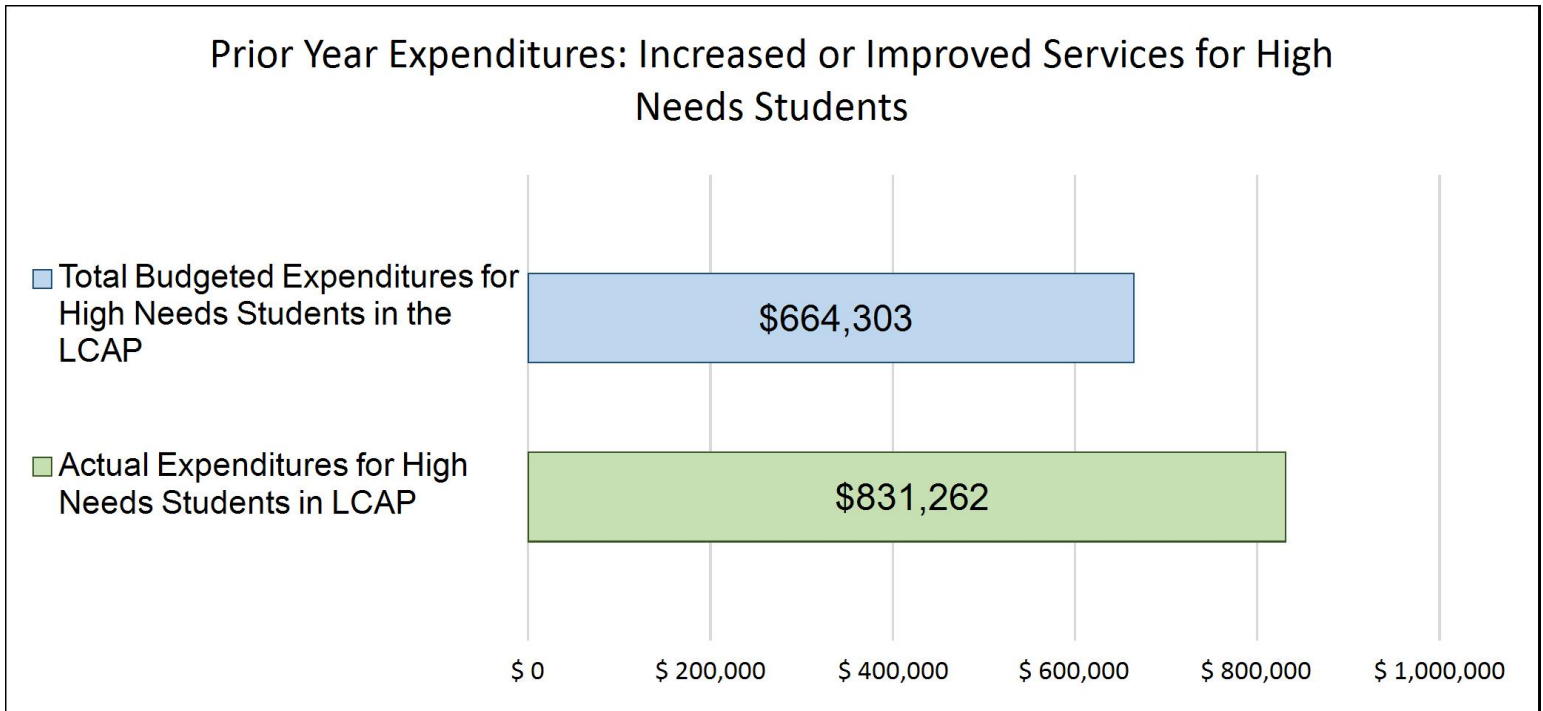

In 2023-24, Natomas Pacific Pathways Prep. Middle School is projecting it will receive \$444,778 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Natomas Pacific Pathways Preparatory Middle School (NP3 Middle) is a charter school authorized by the Natomas Unified School District. The School serves approximately 505 students. Approximately 80% of the students reside in the Natomas Unified School District’s boundaries, with the remaining coming from outside of the area. The School’s unduplicated pupils comprise 44% of the School’s student body population. NP3 Middle promotes students who are thoughtful, prepared, and engaged citizens. The School emphasizes conceptual understanding, and teaches the Common Core State Standards through year-long themes. The School focus on understanding, evaluating, and creating with the goal of providing our children the tools for citizenship and life. NP3 Middle has been recognized as a Gold Ribbon School, received the Civic Learning Award for Excellence, and was recently recognized with a Distinguished School award.

Reflections: Successes

NP3 MS continues to provide a high-quality education to the diverse student population. A review of available data and reports shows that NP3 MS has performed well, for example, in 2022, NP3 Middle School received High ratings for ELA and Math performance on the CA School Dashboard. On the English Learner Progress Indicator, the school rated Very High. The suspension rate indicator had a Medium rating and the school also had Low chronic absenteeism.

When compared to 7 similar middle schools across the state with enrollments within 200 students of our school and unduplicated rates within 20%, no school performed higher on any of the state indicators.

When looking at 2022CAASPP results and student achievement, 2/3 of the students met ELA standards and half the students met Math standards, this is a 4% increase in ELA and a 3% decrease in math, but note that the state results showed 4% and 6% decrease from the 2019 test.

Reflections: Identified Need

There are some opportunities for improvement. When looking at student achievement, English Learners and Students with Disabilities had the lowest performance on both ELA and Math in 2022. Socioeconomically Disadvantaged students and Latinx students also had lower math performance than other groups. Also, while the overall chronic absentee rate is low at 3.7%, for Students with Disabilities the rate was high at 12%; English Learners was 8%, Students of Two or More Races was 7%, and White students was 7%. The Suspension rate was low at 2.3% but the following groups had suspension rates twice as high as the school average: English Learners (6.3%), Students with Two or More Races (6.8%), Students with Disabilities (4.8%) and White Students (6.6%).

NP3 MS conducted a survey of our families in the Spring of 2023 to gather feedback about distance learning. School leaders communicate regularly with staff and families through a variety of methods including weekly emails, website updates, and regular communications from teachers. Staff meetings were held regularly throughout the year along with an 8th grade information night, and safety meetings about in-person instruction.

A summary of the feedback provided by specific educational partners.

Based on the feedback from our educational partners a few things stand out. For example, our partners feel like our school does a lot of things well, including academics, school climate, student engagement, and student wellness. Parents clearly want to be involved as well. Teachers may not realize how much they're sharing and how much the administration is listening to their ideas. There is a need to do more family events and student activities. Finally, the next time, in student survey, we need to make the questions about "teachers" specifically, because "staff" is not a term that makes interpreters that it includes teachers.

Through the annual LCAP survey, educational partners shared strong support for NP3, instructional programs and support for students. A separate survey was administered to students than parents/families and staff. The following results include the percent of parents/family and staff who agreed or strongly agreed with each statement, and the percent of students who said the statement was partially true, mostly true, or completely true.

Educational partner input led to a number of changes and additions to the plan for reopening schools in 2021 including: the purchase of technology devices and mifi internet devices for students; additional trainings provided to NP3 staff; and a focus on student engagement and support by teachers, counselors, and other staff; childcare assistance for staff. Moving forward, out of the Pandemic, the feedback from our educational partners has also influenced school systems and processes and will be used to plan for changes in school structures using what we've learned through distance learning. Many of these same actions will continue into 2023-2024.

With the new three-year LCAP, using educational partner feedback and informed by student data, school leaders reflected on previous goals and established new schools to carry the school forward into the next few years. Along with maintaining goals focused on outstanding academic programs, preparing students for their future, and creating safe and engaging school environments, the new goal was developed, focused on civics education. This new goal reads: "NP3 will provide equitable access to a broad course of study that is rigorous, culturally responsive, and relevant to promoting globally minded and civically engaged students."

These contributing actions are principally directed toward our unduplicated student population to help NP3 be effective in meeting the goals and the identified needs of the unduplicated student groups.

In the goals section of this plan, each action marked “yes” for contributing contains a detailed explanation of how that action is principally directed toward the unduplicated student population and effective in helping close equity and performance gaps and meet the goals of our LEA. After assessing the needs, conditions, and circumstances of our English Learners, Low Income Students, and Foster Youth students, we learned that their chronic absentee rate was higher than the chronic absentee rate for all students. These actions are being provided on a school-wide basis with the expectation that it will also benefit all students to improve their chronic absentee rate. However, because of the higher chronic absentee rate for these English Learners, Low Income Students, and Foster Youth, and because the actions meet needs most associated with the chronic stresses and experiences of family challenges, financial issues, feelings of connectedness to school we expect that the chronic absentee rate for our English Learners, Low Income Students, and Foster Youth students will increase more than the average chronic absentee rate of all other students.

After assessing the needs, conditions, and circumstances of our English Learners, Low Income Students, and Foster Youth students, we learned that their academic achievement was lower than the academic achievement for all students. These actions are being provided on a school-wide basis with the expectation that it will also benefit all students to improve their academic achievement. However, because of the lower academic achievement for these English Learners, Low Income Students, and Foster Youth, and because the actions meet needs most associated with the chronic stresses and experiences of financial resources available to purchase a home computer we expect that the academic achievement for our English Learners, Low Income Students, and Foster Youth students will increase more than the average academic achievement of all other students.

After assessing the needs, conditions, and circumstances of our English Learners, Low Income Students, and Foster Youth students, we learned that their chronic absentee and suspension rates was higher than the chronic absentee and suspension rates for all students. To address this condition of our English Learners, Low Income Students, and Foster Youth students, we will provide counseling supports, a school-wide focus on restorative practices, and transportation services to address some of the major causes of higher chronic absentee and suspension rates, including lack of social emotional issues, connections with other students, and transportation to school.

These actions are being provided on a school-wide basis with the expectation that it will also benefit all students to improve their chronic absentee and suspension rates. However, because of the higher chronic absentee and suspension rates for these English Learners, Low Income Students, and Foster Youth, and because the actions meet needs most associated with the chronic stresses and experiences of social emotional issues, connections with other students, and transportation to school we expect that the chronic absentee and suspension rates for our English Learners, Low Income Students, and Foster Youth students will increase more than the average chronic absentee and suspension rates of all other students.

Using the calculation tool provided by the state, our LEA has calculated that it will receive \$444,778 in Supplemental and/or Concentration funding under the Local Control Funding Formula (LCFF). The proportionality percentage to increase or improve services has been calculated at 8.14%. Our LEA has demonstrated that it has met the 8.14% proportionality percentage by planning to expend 18% which is

more than the minimum required supplemental and/or concertation funds on actions or services such as extra time for learning, counseling support, cultural awareness, and academic interventions that are principally directed towards the unduplicated student population as summarized in the prompt above and as explained in detail in each contributing action description within this plan.

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

COEs and Charter Schools: Describe how actions included as contributing to meeting the increased or improved services requirement on an LEA-wide basis are principally directed to and effective in meeting its goals for unduplicated pupils in the state and any local priorities as described above.
