The Natomas Unified School District supports and respects each family's right to decide to allow for or request the denial of use of District Technology and/or District Network.

STUDENT USERS

I HAVE READ and understand the provisions of the Natomas Unified School District Student Use of Technology Board Policy 6163.4 and the Administrative Regulation 6163.4 that are available on our district website at <http://natomasunified.org/board-of-trustees/board-policies-and-administrative-regulations/>.

By using any District Technology or otherwise accessing the District Network on District premises I understand and agree to abide by the provisions and conditions of this policy as well as with any and all District policies and rules which may relate to usage of District Technology and/or the District Network. I also understand that my use of the Internet and electronic communications via District Technology is strictly limited to educational purposes, that I am not guaranteed any rights to privacy with respect to use of the District Technology, including use of District-Owned Devices and the District Network, and that from time to time the District may monitor the District Network for general security purposes and in order to ensure compliance with Board Policy, Administrative Regulation and this Agreement.

NUSD utilizes a software tool with students using Natomas Unified School District (NUSD) to monitor content concerning behavior that may be detrimental to students' safety. In addition, this software tool provides teachers a single screen update with the current status of each student, ensuring they are remaining on task and/or completing their task, such as an assessment, during the allotted time.

It is important to know that **when one of our students logs into their NUSD account**, on any chromebook, Ipad, Macbook, etc, regardless if the device is NUSD-issued or not, the software program will be monitoring.
